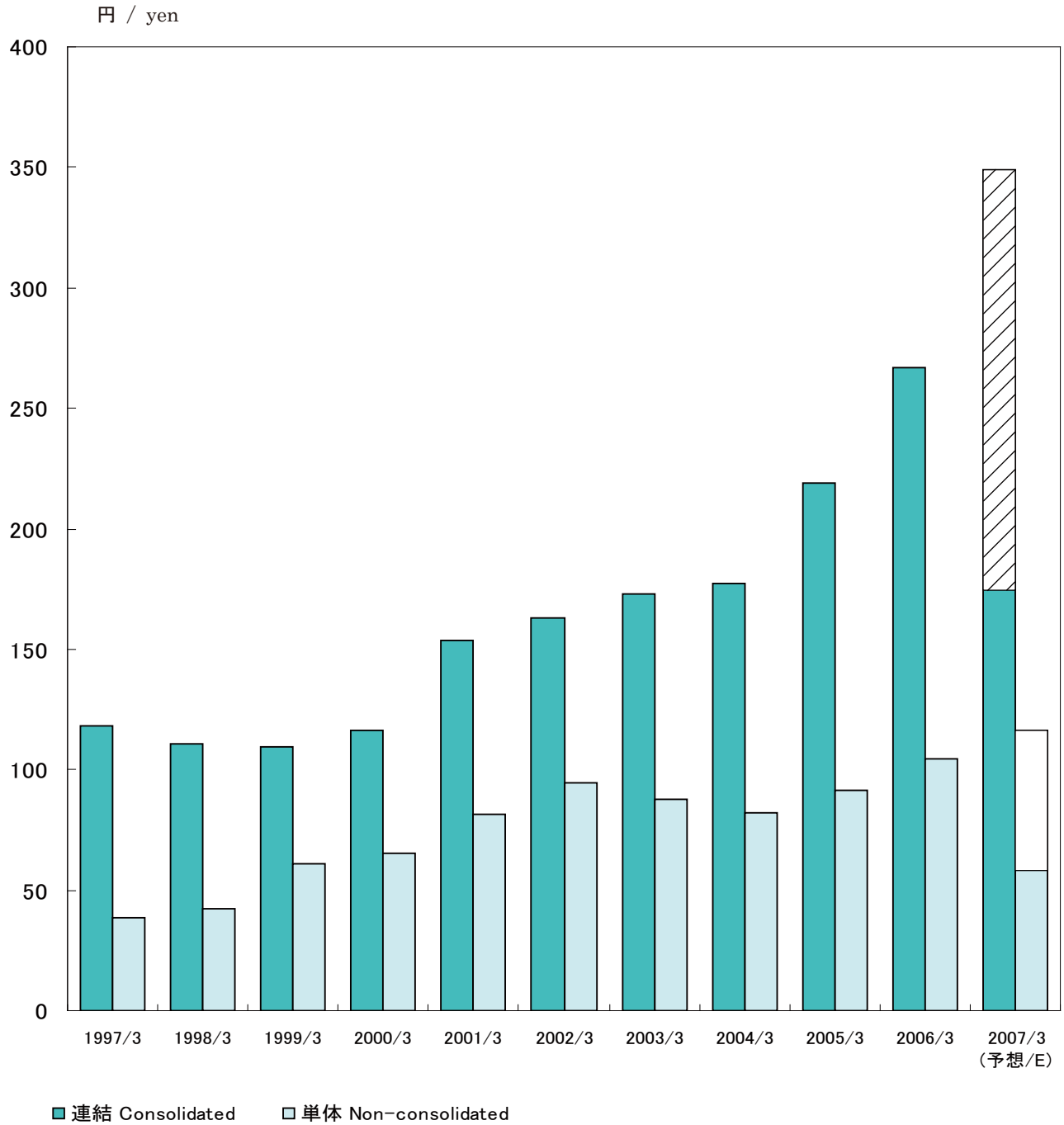

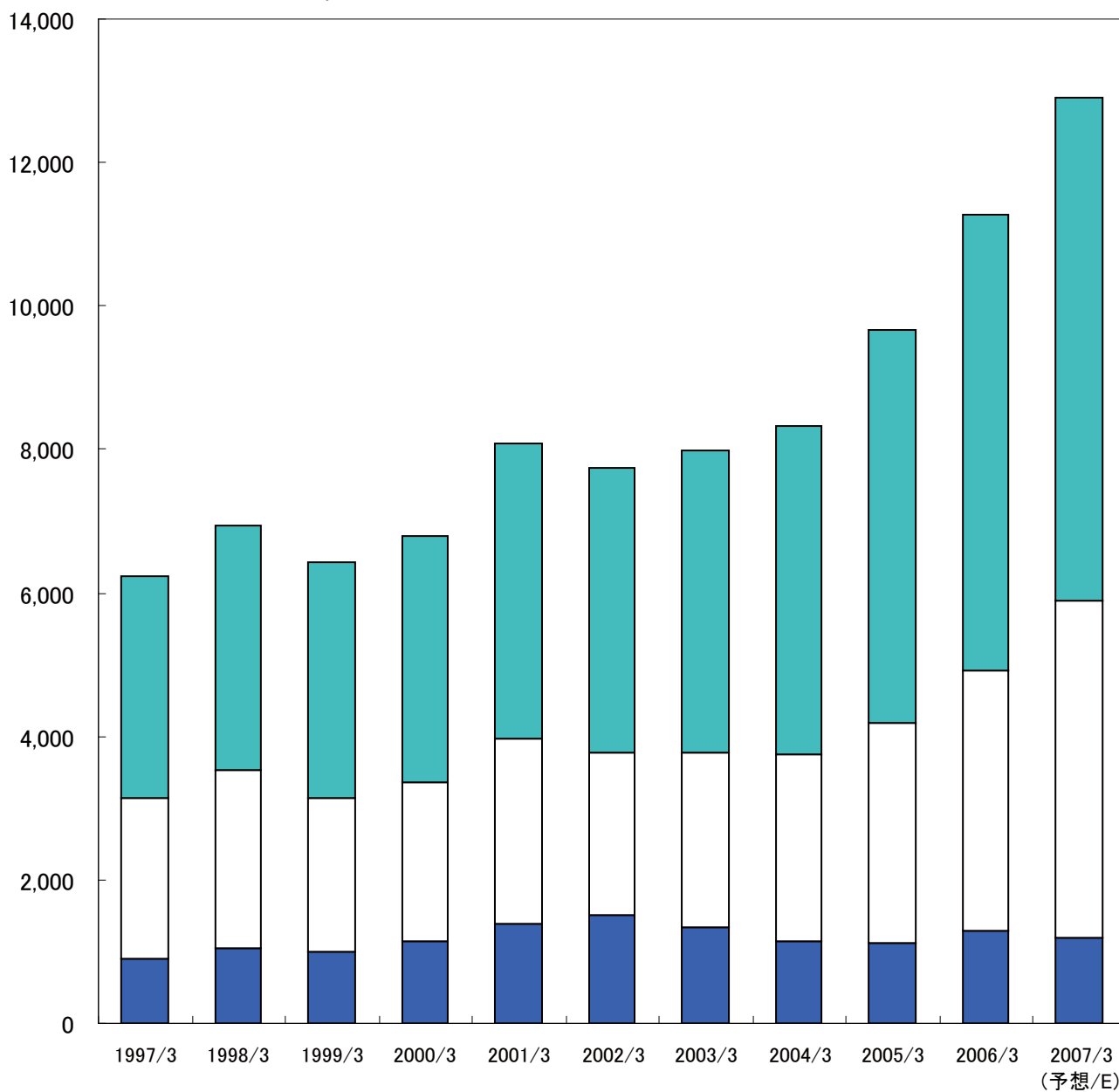

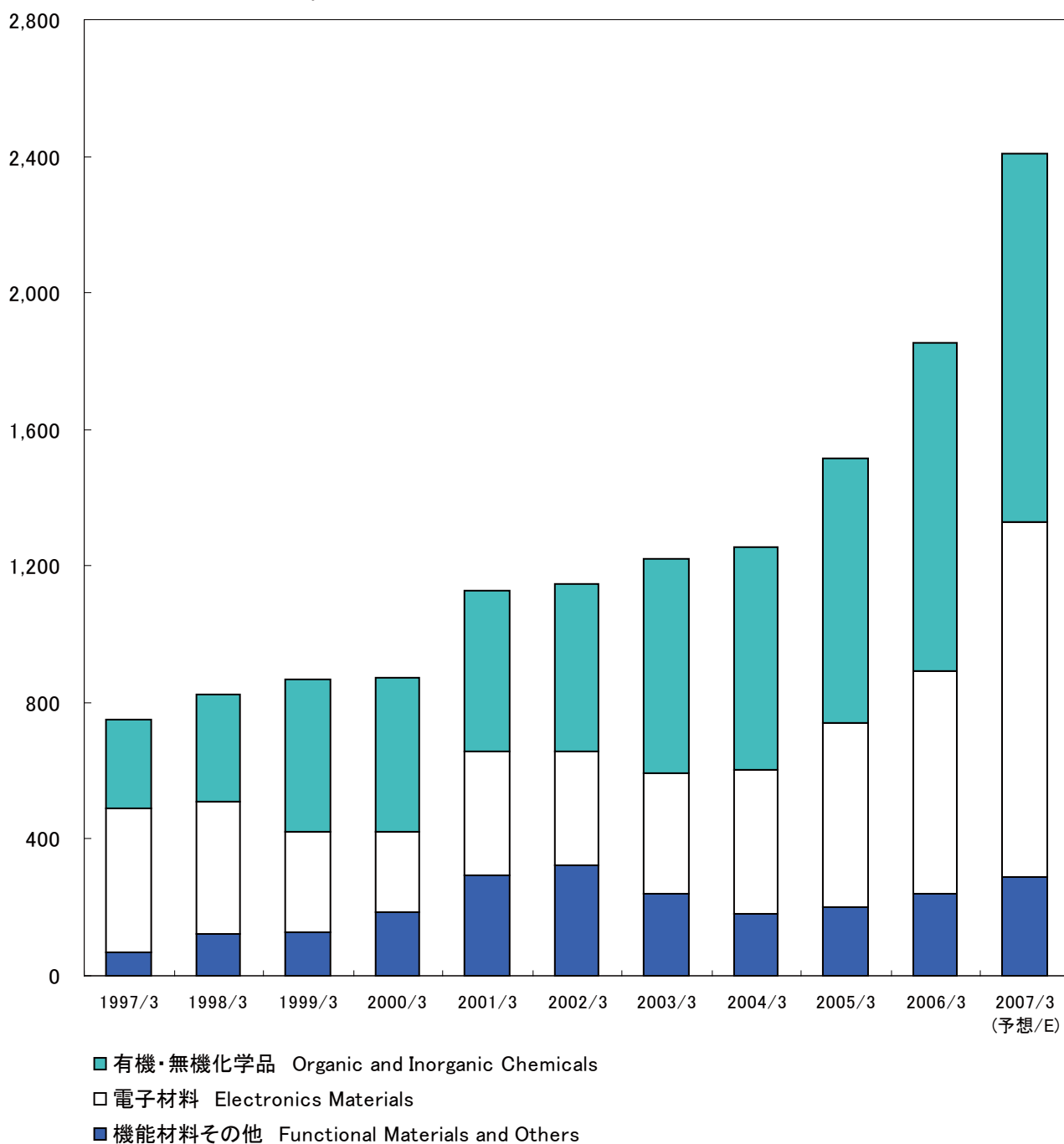

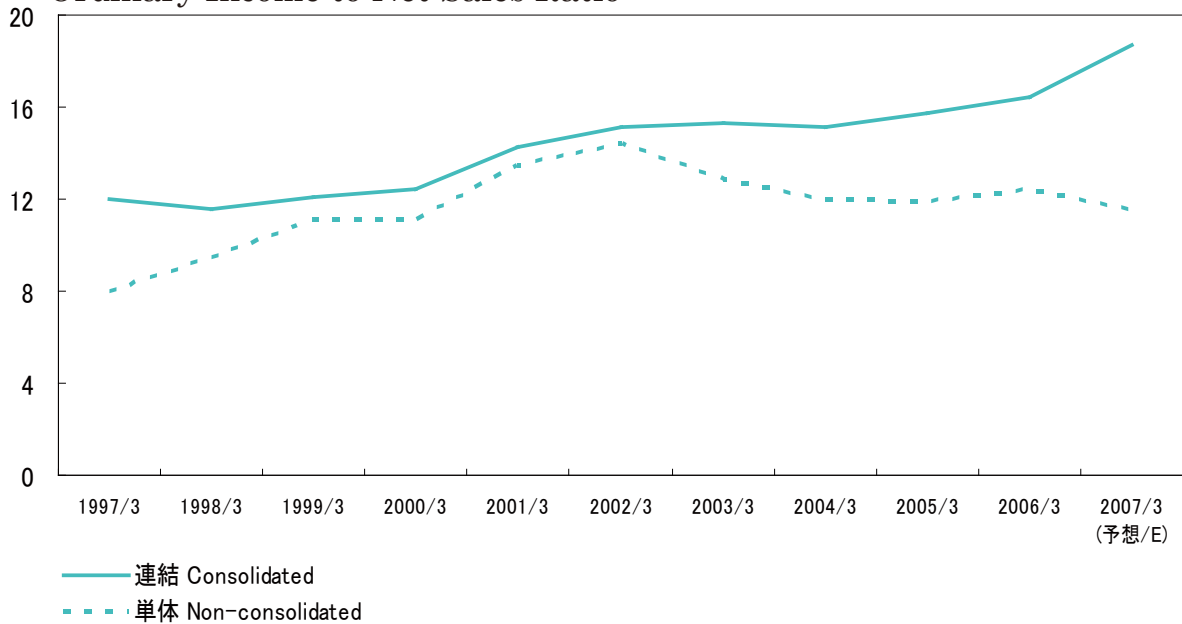

売上経常利益率 Ordinary Income to Net Sales Ratio



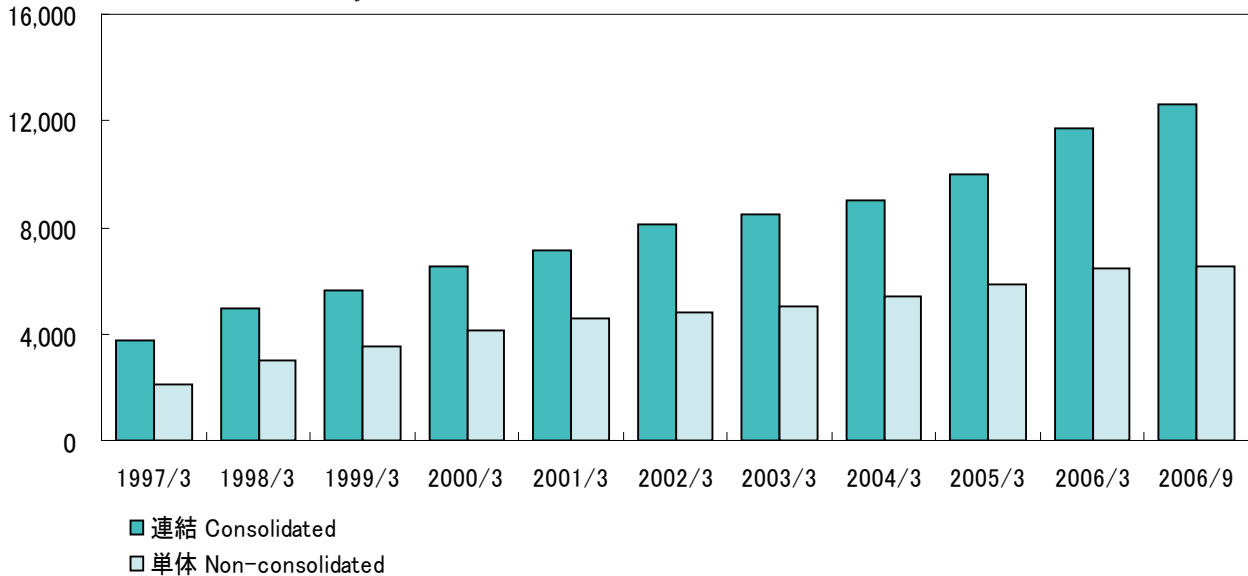
売上高当期純利益率 Net Income to Net Sales Ratio

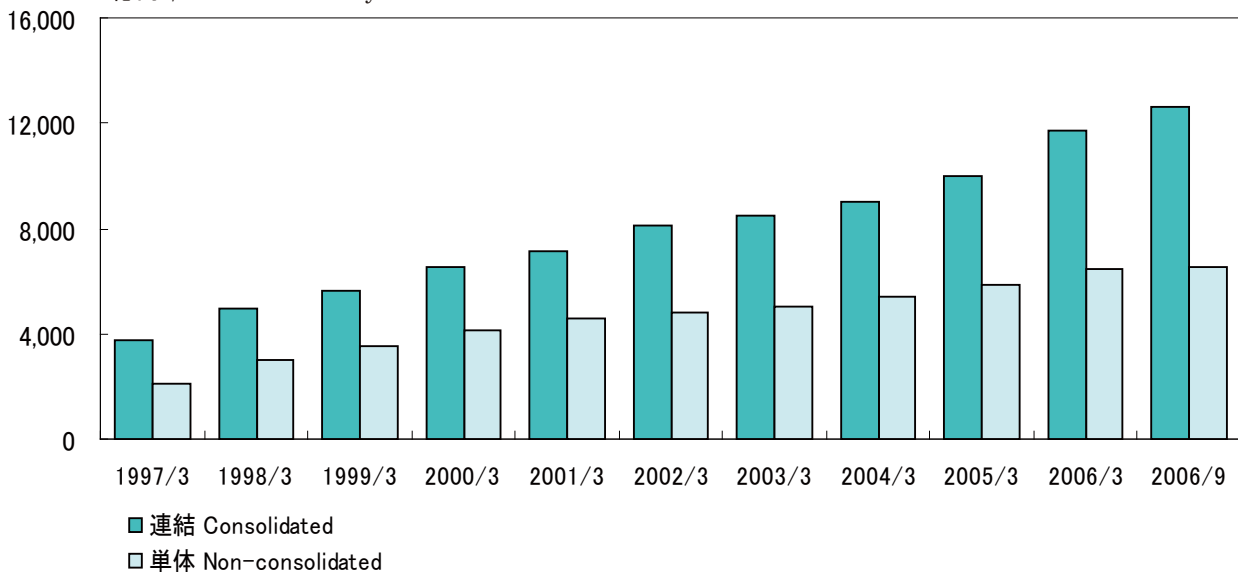

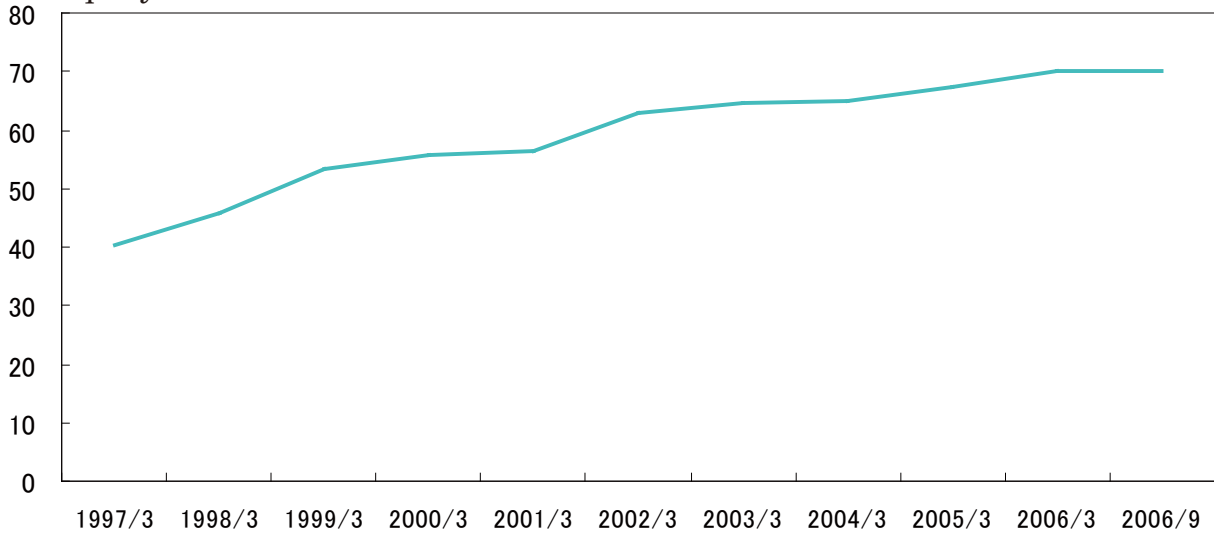

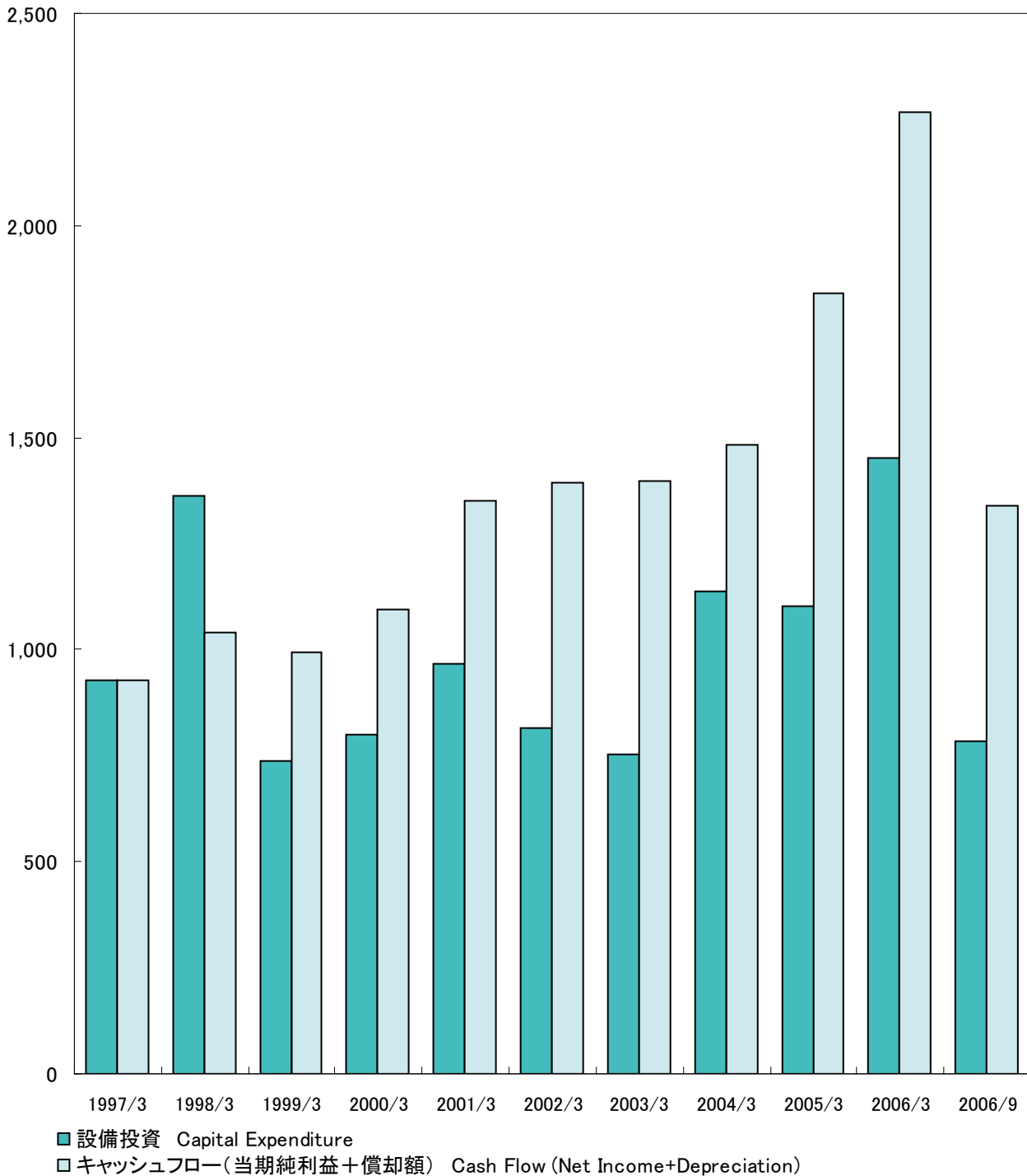
