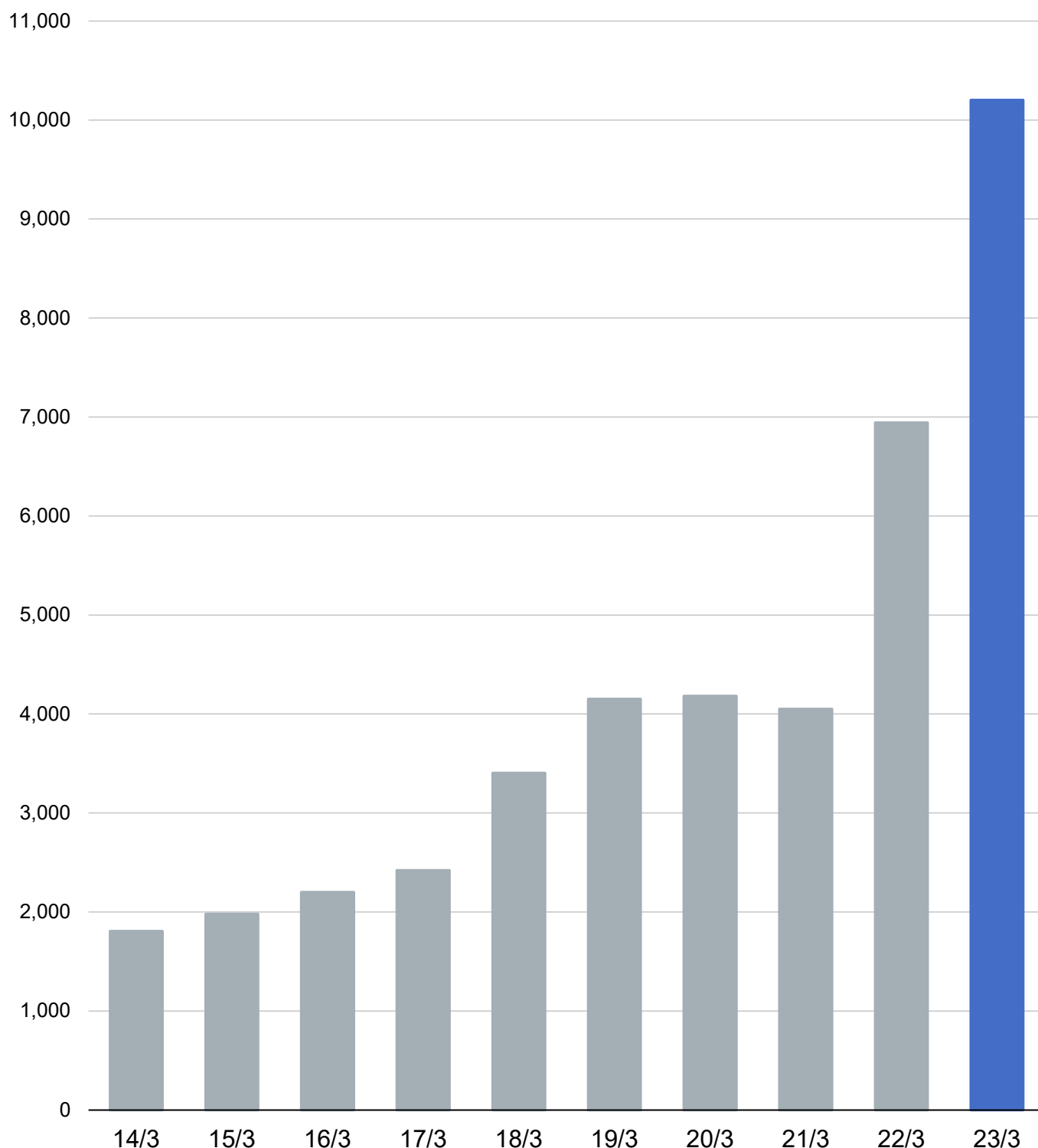

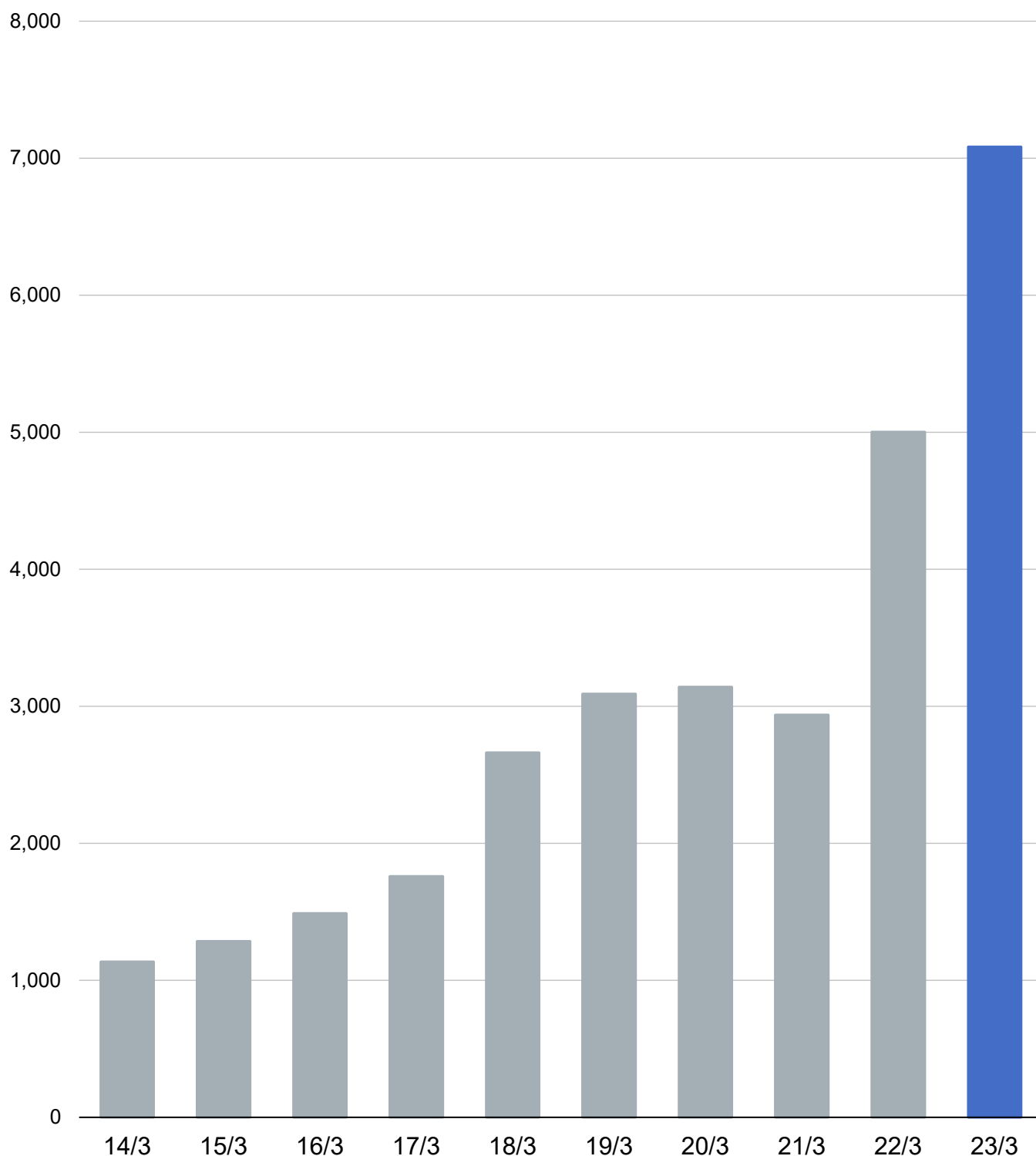

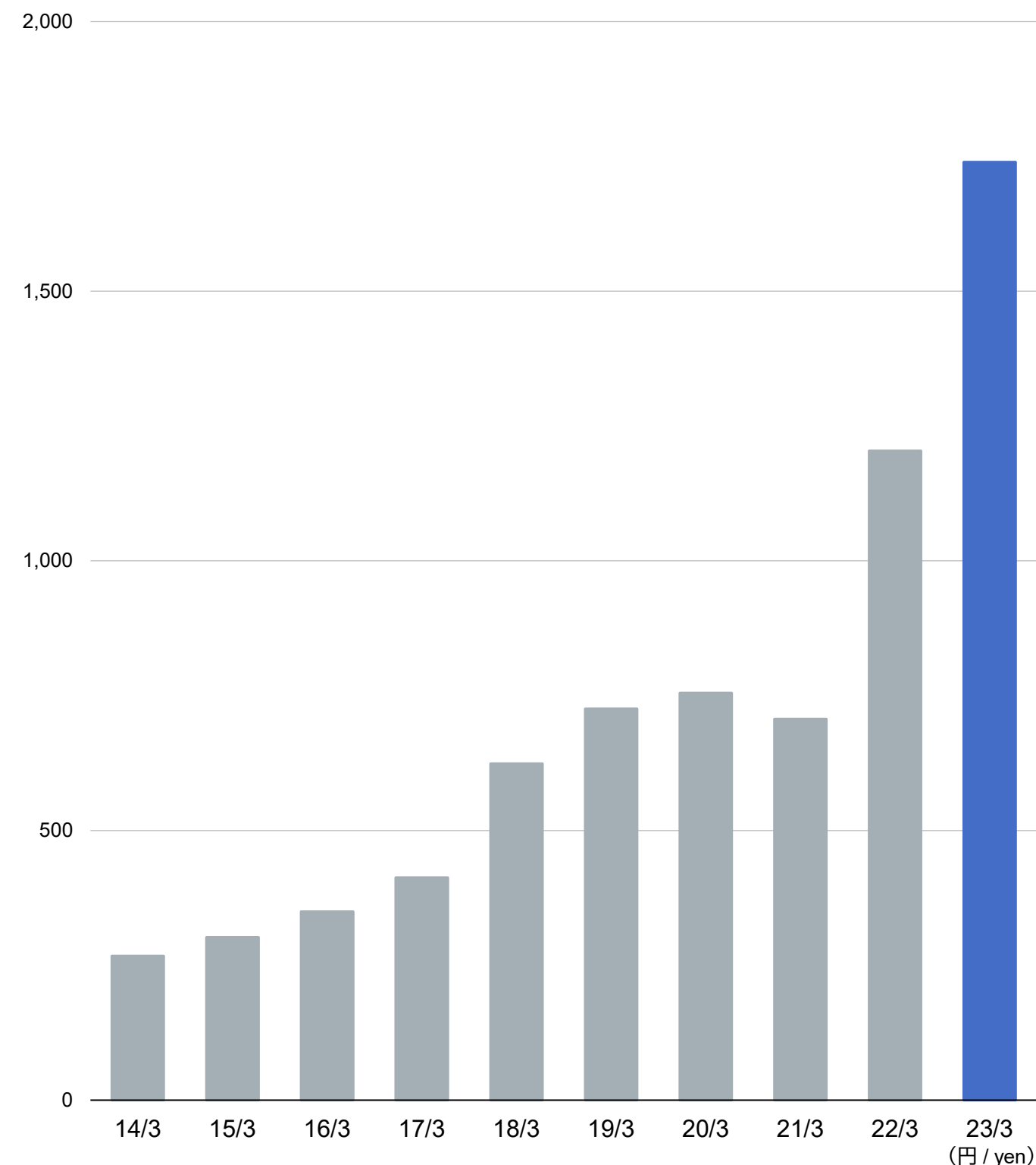

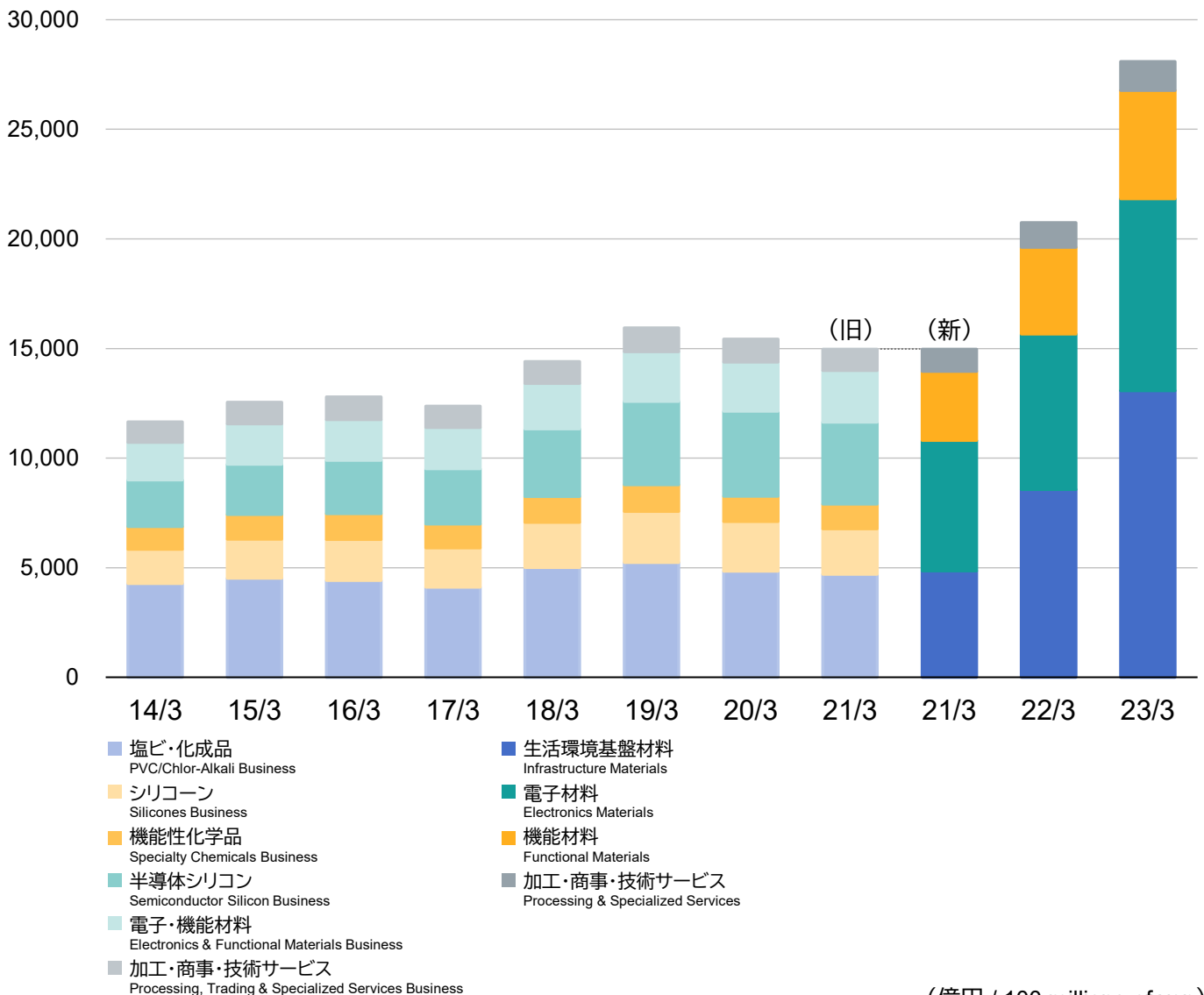

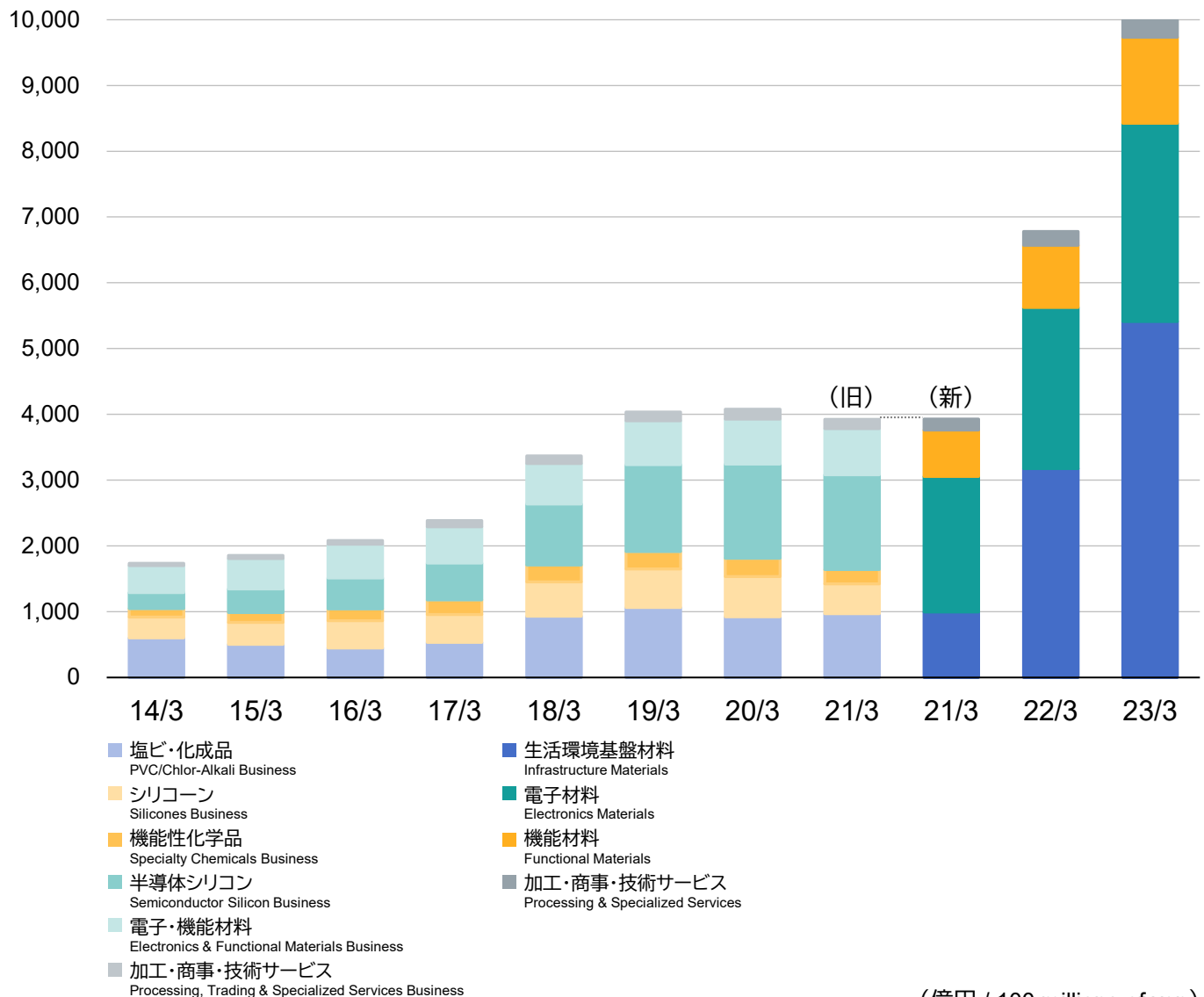

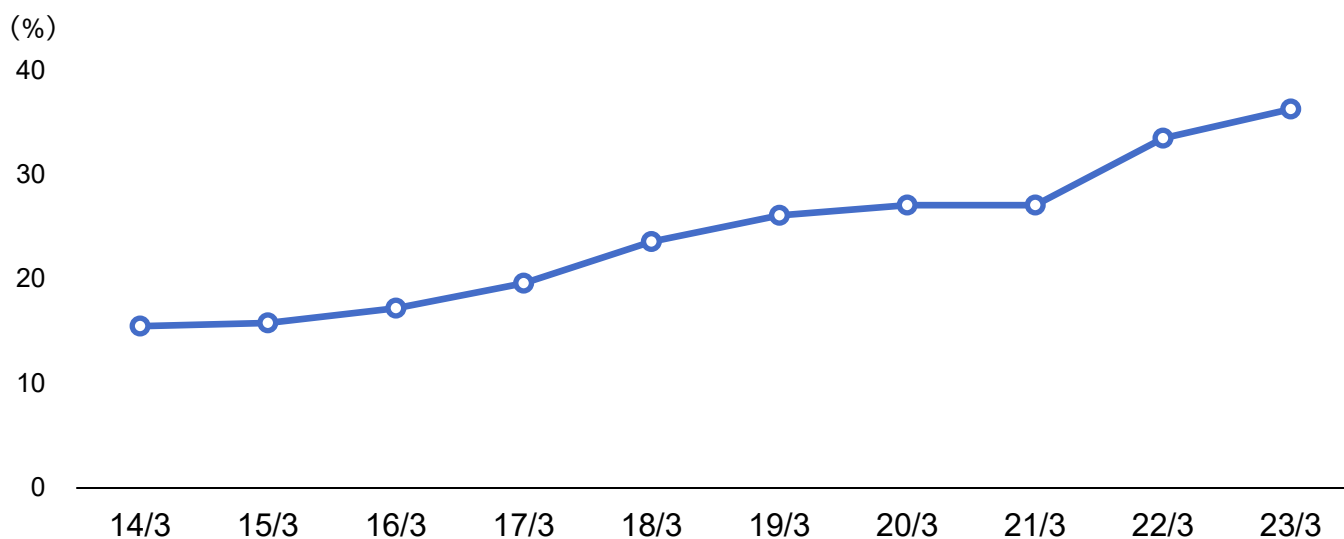

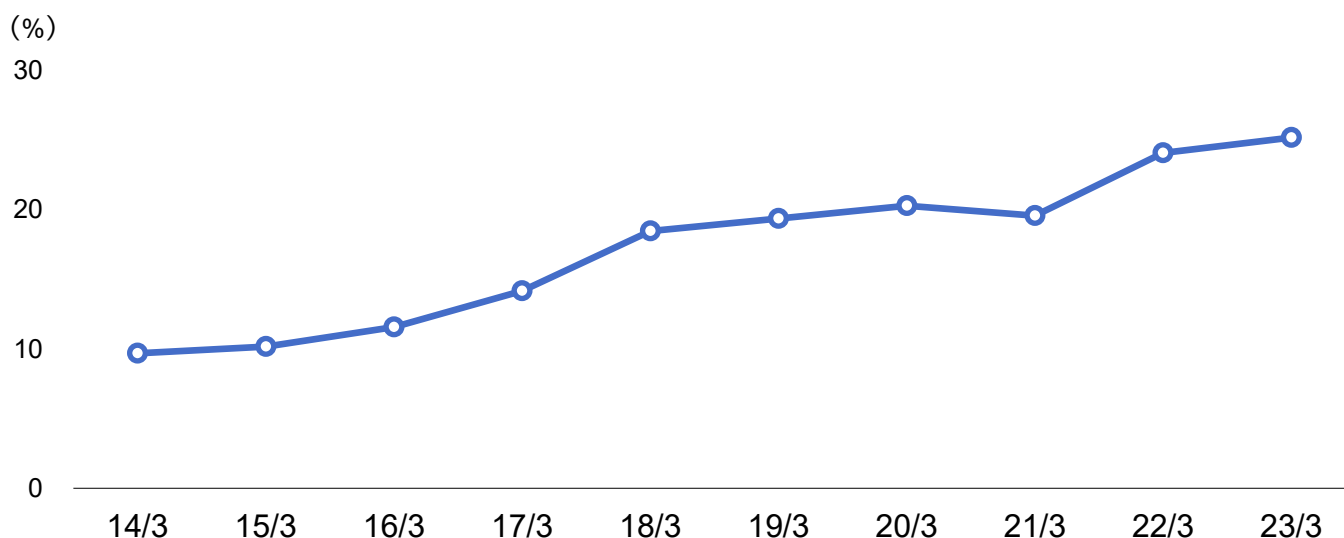


Ordinary Income to Net Sales Ratio, Net Income Attributable to Owners of Parent to Net Sales Ratio

売上高経常利益率 Ordinary Income to Net Sales Ratio



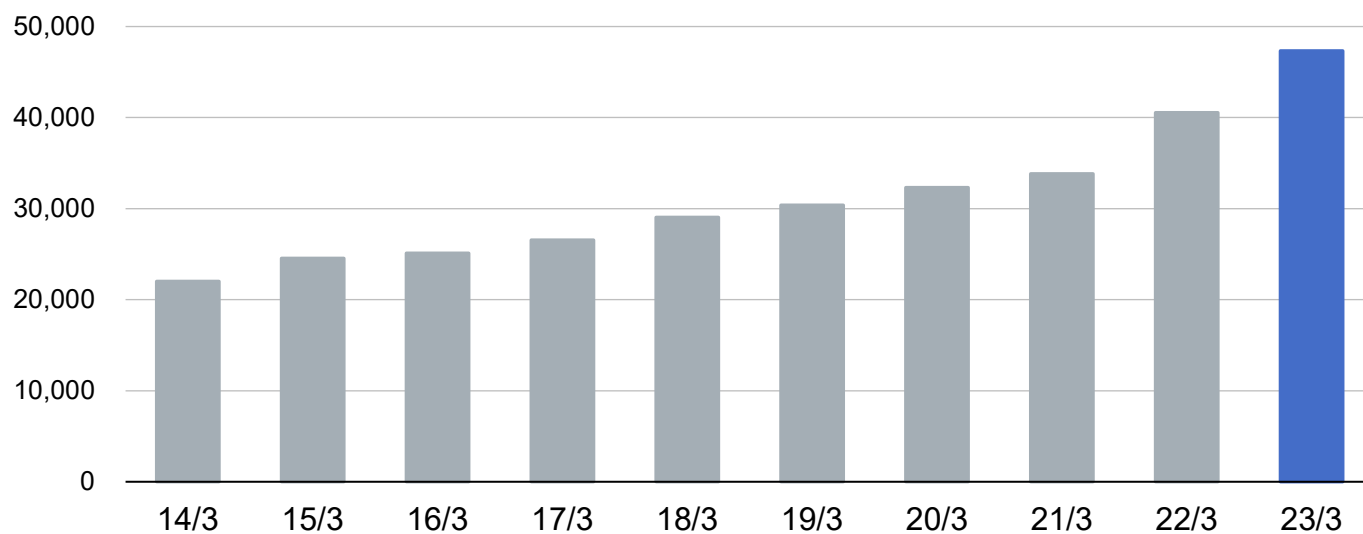

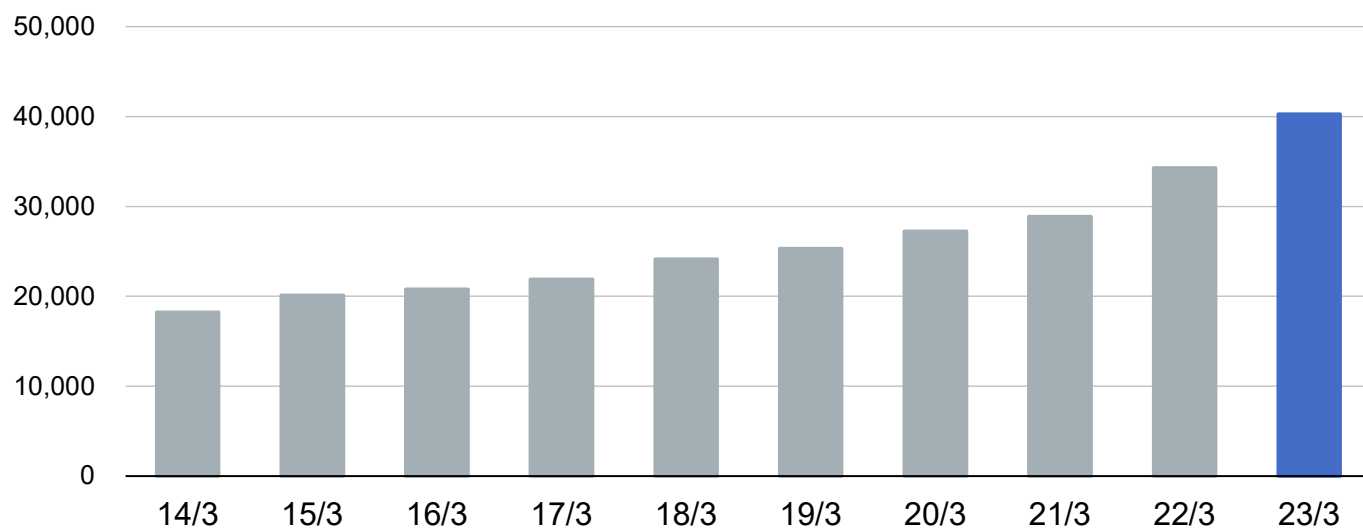

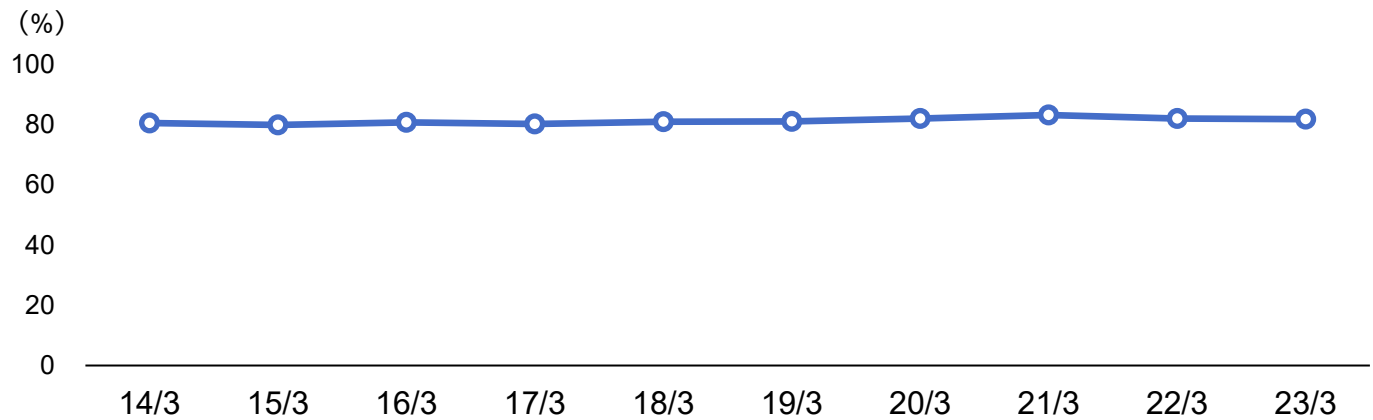

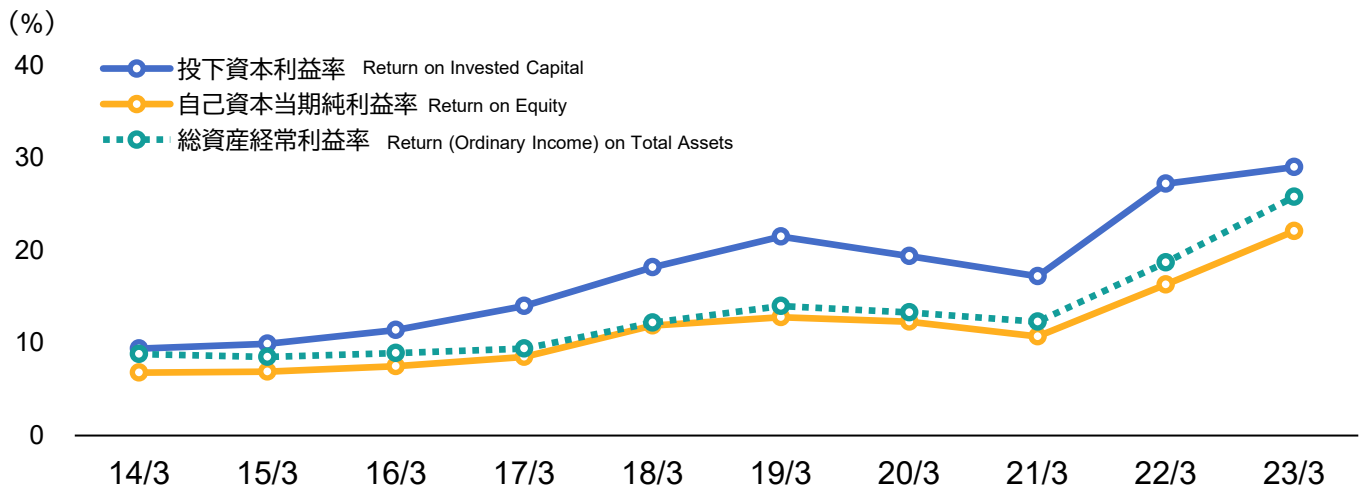
Equity Ratio, Return on Invested Capital, Return on Equity, Return (Ordinary Income) on Total Assets

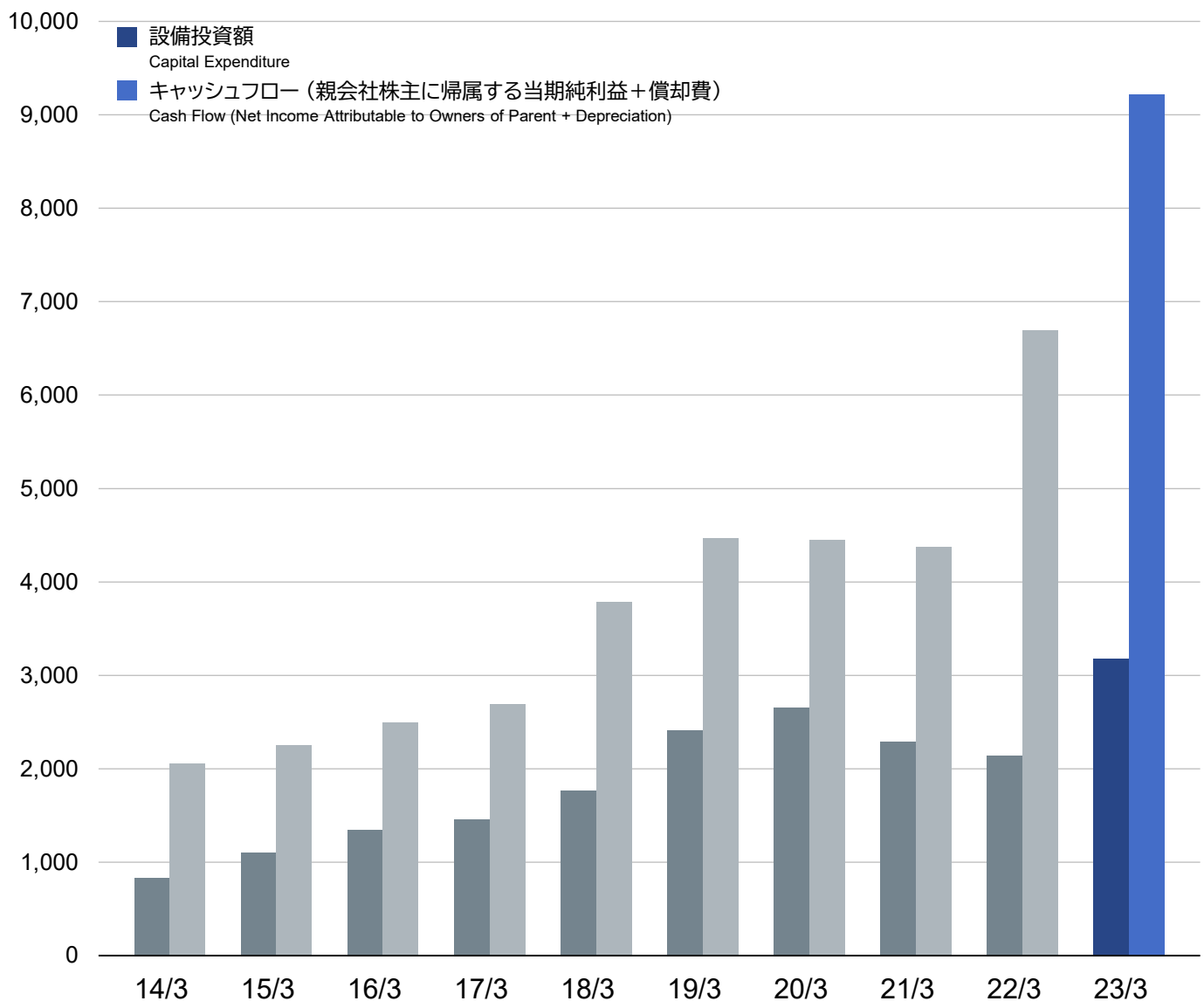
